## Kemper's unemployment rate shows slight increase

Kemper County's May 2021 unemployment rate of 8.1 percent stayed about the same when compared to the previous month.

Unemployment in Kemper County edged up 3/10ths of a percent when compared to the April 2021 rate, according to the Mississippi Department of Employment Security.

That's much better than this time last year in the midst of the COVID-19 Pandemic, Kemper County's unemployment rate stood at 11.8 percent. Businesses and industries were forced to halt operations and send their employees home to avoid infection. At that time, Mississippi's unemployment rate stood at 11.8 percent while the nation's climbed to 13.0

Kemper County's labor force in May 2021 stood at 3,500 people, an increase of 60 when compared to the previous month. Of that, 290 people were out of work.

Here is a look at the unemployment rates in neighboring counties.

Mississippi's not seasonally adjusted unemployment rate for May 2021 was 6.1 percent, increasing two-tenths of a percentage point from the previous month's rate of 5.9 percent. When compared to May 2020, the rate decreased 5.4 percentage points over the year.

The number of unemployed increased 2,200 over the month, while the employed total increased 1,400. The Nation's unemployment rate for May 2021 of 5.5 percent decreased two-tenths of a percentage points over the month

## Choctaw Indian Fair opens in two weeks

The 71st annual Choctaw Indian Fair officially starts in two weeks with a long list of events and activities planned for the four-day event.

But the fun begins next week. The Fair is held at the Pearl River Community on the Choctaw Indian Reservation in Choctaw.

A favorite part of the Fair is the World Series of Stickball, which actually starts Wednesday.

"On July 7, we are going to open it up with a ceremony honoring our stickball coaches and play-

ers who have passed on," said Misty Brescia, director of the office of Public Relations for the Mississippi Band of Choctaw Indians. "That starts at 7 p.m. Then we are doing two exhibition games afterwards, a women's 35-and-over and a men's 50-years-and-over."

The World Series Stickball tournament has three adult divisions - Men's, Women's, Men's 35-and-over, and two youth divisions - Tulli Okchi Ishko (14-17) and Pushmataha (10-13). Stickball will continue until the Saturday, July 17, with the men's championship game on the final night of the Fair.

The Fair officially gets underway Wednesday, July 14, at the Amphitheater with the Opening Ceremonies at 6 p.m., followed by the Choctaw Indian Princess pageant starting at 7 p.m. The title of Choctaw Indian Princess is a very prestigious title that holds many responsibilities. The princess serves as an ambassador for the Tribe for one year. During her reign, she travels around the country, many times with the Tribal Chief, to promote awareness of the Tribe.

As always, there is professional entertainment at the Amphitheater. The acts are as follows: Thursday - Jimmie Allen at 8:30 p.m.; Friday -

Zach Williams at 8:30 p.m.; and, Saturday - Brett Young at 8:30 p.m.

A new event this year will be the CIF Cornhole Tournament. According to Internet sources, cornhole (also known regionally as bags, sack toss, or bean bag toss) is a lawn game in which players take turns throwing 16 ounce bags of corn kernels at a raised platform (board) with a hole in the far end. A bag in the hole scores 3 points, while one on the board scores 1 point. Play continues until a team or player reaches or exceeds the score of 21 by means of cancella-

# Enjoy July 4 celebration with low carb recipes

Happy Independence Day. This is the time of good food, fellowship, and fun. Just remember to make sure you have low carb options for your snacks and meals.

Pack sliced vegetables such

as carrots, peppers, cucumbers and squash. Bring your favorite low carb dressings, olive oil or just good old salt and peppers. Keep pork rinds and rice cakes for your salty cravings. Both have a variety of flavor choices so you don't have to be bored with them.

Pack flavor bombs, dark chocolate pieces or fruit for

your sweet options. Be sure there is grilled, broiled, or air fried meats. Here's some recipes to help with the planning.

**LOW CARB COLE SLAW**  
1 head of green cabbage  
2 to 3 carrots  
2/3 cup mayonnaise  
1/3 cup unflavored Greek

Yogurt  
1/4 cup Swerve or low carb sweetener of choice  
1/4 cup apple cider vinegar or white vinegar  
2 tablespoons of Dijon mustard  
Start by cutting the cabbage in half. Remove the core and wash it well. Also give the carrots a good scrub. Set the cab-

bage aside and allow the water to drain out.  
Using a hand grater or a food processor, shred the carrots and place in a large mixing bowl. Shred the cabbage in the food processor if you have one. If you don't have one big enough to put cabbage in, just sliced it thinly with a knife.  
In a bowl, mix the granulat-

ed sugar and the cider vinegar together. Stir until most of the it has been dissolved. Add the mayonnaise and Dijon mustard. Mix until well blended.  
Pour the dressing over the cabbage/carrot mix and stir to coat. Transfer the coleslaw to a large container with a cover. Or

### Acts 10:1-23

The Lord had promised to build His church, beginning in Jerusalem and then spreading to Judea, Samaria, and the ends of the earth (Acts Chapter 1). Thus far in Acts we have seen the gospel spread in the Jewish cities as promised. Many have been converted through the good news that Jesus came to take away sin, vanquish death, and break the power of Satan.

and that only Christ can do that. The Jewish ceremonial laws were enacted by Moses to teach Israel to be separate from the corruption of the nations, and to be holy unto God.

Now the gospel will go to the Gentiles, or to the nations. Luke tells us about Cornelius, a Roman centurion, who is a Gentile (Acts 10: 1). He was a devout man who feared God, and gave generously. This means he believed in the God of the Old Testament, the Lord of Israel.

All of the constant washings, sacrifices, dietary laws, and other Jewish ceremonial laws pointed to the need to be pure before God. They all pointed to the need we have of Christ; the washings, His cleansing; the sacrifices, His atoning sacrifice; the dietary laws, the need to be pure in heart toward Him. Christ was the fulfillment of all these laws, so they are abrogated by his coming and work.

We are also told he prayed continuously (verse 2), and one day when he was praying he saw a vision of an angel. The angel told him that his prayers and aims had ascended as a memorial to God. For the Lord to be well pleased with them meant Cornelius prayed and gave from a humble, thankful heart. No sinful man can do this without also sincerely confessing his sins.

The repetition of the vision to Peter was to emphasize that the Lord's plan is to make Gentiles clean and part of the church. They too, like the Jews, would be cleansed from sin and the corruption of the world. There is no difference in Jew and Gentile; both can be made right with God through the blood of Christ.

The angel instructs Cornelius to send men to Joppa where Peter was staying at the time, and the centurion immediately complies. As the men he sent draw near to Joppa, Luke tells us that while Peter was praying, he went into a trance, and the Lord gave him a vision of a sheet descending from heaven filled with all kinds of living animals.

The astounding thing to Peter and the Jewish Christians is that the Lord would call the corrupt Gentiles to be his people. They were far from God, without hope and without God (Ephesians 2:12). This should astound us as well. Salvation is undeserved and we may rightly tremble before God, but when the Father sees the blood of Christ we are safe.

The voice of the Lord commands Peter to "Rise, kill, and eat (verse 13)." Peter objects because as a devout Jew he had never eaten unclean animals, which were forbidden in the ceremonial laws of Israel. The Lord tells Peter to not call common what he has made clean and this same interaction happened three times, and then the vision was over.

We may rest in calm security. We have God's Sacrifice and God's word to create in us a sense of perfect security. He will spare us, because he did not spare his Son. We should be joyful in this truth and be careful of pride and boasting in light of it.

While Peter is puzzling over the meaning of the vision, the men from Cornelius were out by the gate of the house asking for him by name. The Spirit of the Lord tells him to go to them and not hesitate to accompany them. Peter invites them in and will go back with them to see Cornelius.

Peter had revulsion at eating anything unclean. The Lord, with his holy nature, is rightly repulsed by our corruption, and the uncleanness of our hearts (Matthew 15:10-20). If Christ doesn't wash us, we can't be clean or acceptable to him. We can't wash ourselves.

But we will pause in the story at this point to think of the meaning and application of what we have read. The first point is the need we have to be made clean before God

But the Lord will take us in. Jesus never repulsed a humble sinner who came to him. He ate and drank with sinners. He said it was the sick that were in need of a physician. There will not be any lost souls who can say "I went to Jesus but he refused me." It is not possible that you would be the first person to whom Jesus shall break his word. He casts out none who come to him.

simply cover the mixing bowl with plastic wrap. Chill in the refrigerator for a few hours before serving.

**SOUTH WESTERN TWICE-BAKED SWEET POTATOES | LOW-CARB**  
 4 sweet potatoes  
 1 lb. ground beef  
 1 small onion, diced  
 1 green bell pepper, diced  
 1/4 tsp sea salt  
 1/4 tsp freshly ground black pepper  
 1 1/2 tsp cumin  
 1/2 tsp smoked paprika  
 1 c shredded Monterrey Jack cheese

To begin, preheat your oven to 400 degrees.

Wash the sweet potatoes and poke them several times with a fork. Set them on a baking sheet and bake for 50-60 minutes or until they are cooked. Once they are done, remove them from the oven, but do not turn it off yet.

While they are baking, cook the ground beef, onion and pepper together in a skillet, breaking up the meat as it cooks. When it is cooked, stir in the salt, pepper, cumin and smoked paprika.

Carefully cut a slit in each potato and scoop most of the insides into a bowl, leaving about a half inch layer of potato on the inside of the skin.

Add the meat mixture to the bowl with the sweet potato and stir it together to combine.

Spoon the mixture back into the potatoes and bake for 10 more minutes.

After they have finished baking, spread the shredded cheese.

### LOW CARB BROCCOLI CASSEROLE

22 oz. frozen broccoli florets  
 1 Tbsp butter  
 1/2 cup onion diced  
 2 cloves garlic minced  
 salt and pepper to taste  
 2 Tbsp thyme fresh  
 4 cups sharp cheddar cheese

shredded, plus extra for sprinkling over top

4 eggs beaten  
 Defrost broccoli according to package instructions. Put in a colander to drain.

Melt butter in small skillet over medium-high heat. Add onion and garlic and sauté until onions are soft (about 8 minutes). Transfer to a medium-sized bowl.

Add broccoli, cheese, eggs, thyme, salt and pepper to bowl. Stir to combine.

Pour contents into a greased casserole dish. Top with a

sprinkle of cheddar cheese.

Bake at 375 degrees for 30-40 minutes, or until edges are lightly browned.

Allow to sit 5-7 minutes before serving.

### LOW-CARB BLUEBERRY COBBLER

3 cups fresh blueberries  
 1 tablespoon orange juice  
 2 tablespoons sugar, divided  
 3/4 cup almond flour  
 1/4 cup coconut flour  
 1/4 teaspoon salt  
 4 tablespoons cold butter, cut into small pieces

1 large egg, beaten  
 1 teaspoon vanilla extract  
 Preheat oven to 375 degrees F.

Stir blueberries, orange juice and 1 tablespoon sugar in an 8-inch-square glass baking dish.

Combine almond flour, coconut flour, salt and the remaining 1 tablespoon sugar in a medium bowl. Add butter pieces and, using your fingers, incorporate into the dry mixture until crumbly. Add egg and vanilla and stir until fully incorporated. Dollop the biscuit topping onto the berries.

Bake until the berries are bubbling and the topping is browned in spots, 25 to 35 minutes. Let cool for 10 minutes before serving with sugar free ice cream.

# METH: A DEADLY DRUG

**Methamphetamine** is a stimulant drug that is destroying our community. Methamphetamine, also known as meth, is a powerful, highly addictive stimulant that affects the central nervous system. Meth takes the form of white, orderless, bitter-tasting crystalline powder that easily dissolves in water or alcohol. People typically use meth by smoking, snorting or injecting. Meth is man-made from pseudo-ephedrine and other toxic ingredients such as lithium, brake fluid and lye. Meth addiction is so powerful because this drug quickly increases levels of dopamine, a chemical in the brain that produces feelings of pleasure. This makes a person want to use meth again and again to achieve the same rush, which eventually leads to addiction.

**Even taking small amounts of meth, or just trying it once, can cause harmful health effects, including:**

- Rapid or irregular breathing
- Bizarre, erratic, aggressive, irritable, or violent behavior
- Increased blood pressure and body temperature
- Faster breathing
- Loss of appetite, disturbed sleep patterns, or nausea

**Chronic meth use leads to many damaging, long-term health effects (even when users stop taking meth), including:**

- Paranoia, hallucinations, mood disturbances, delusions, or violent behavior (psychotic symptoms can sometimes last for months or years after quitting meth)
- Anxiety, confusion, or insomnia
- Permanent damage to the heart and brain
- High blood pressure leading to heart attacks, strokes, and death
- Liver, kidney, and lung damage
- Intense itching, causing skin sores from scratching
- Severe dental problems ("meth mouth")

**What can you do if a loved one is using meth?**

- Do some research about addiction and meth to have a better understanding
- Be ready to listen, and do not be judgmental
- It is not wise to confront the individual when they are high
- When a person refuses help or services, voice your concern but respect the person's decision
- Self-care is very important when caring for others
